Public Notice Town of Taber Proposed Bylaw 13-2018

The Town of Taber is proposing to amend the Land Use Bylaw 14-2016 to add cannabis uses. If proposed Bylaw 13-2018 is passed, the Land Use Bylaw will add Cannabis Retail Sales as a discretionary use to the Comprehensive Commercial (CC) and Downtown Commercial (DT) districts. The amendment will also add Cannabis Production and Distribution as a discretionary use to the Medium Industrial (M-2) District.

If you are for or opposed to this amendment or would like to express a concern about it, Council would like to hear from you. On Monday, **June 25th, 2018 at 3:30 pm**, Council will hold a PUBLIC HEARING in the Town of Taber Council Chambers to consider the proposed Land Use Bylaw Amendment. Copies of the amending Bylaw 13-2018 may be obtained at the Town of Taber Administration building. If you are unable to attend the public hearing but would like to submit your comments/concerns in writing, please submit them to the Town Office no later than noon on June 19th, 2018.
